Visa Requirements for Foreigners Travelling to Namibia:

All national from African Countries that are holders of Diplomatic/Official and Service Passports are exempted from visa requirements into Namibia. For more information see our Website at: www.namhckl.com.my

Nationals of the following countries are NOT required to obtain a visa when travelling to Namibia for tourism purposes for a maximum period of 90 days, BUT DO NEED visas when on business trips (*Please note definition of business visas below*). **Nationals from countries NOT LISTED under will need visas for both tourism and business purposes.**

Please note definition of business visas below.

1. Prospects to set up formal business in Namibia; 2. Exploratory or fact-finding business missions; 3. Official government visits; 4. Business people attending meetings at subsidiaries of their parent companies; 5. Attending meetings, corporate event (not work) and meetings for which no remuneration is received, 6. Charities, voluntary and expedition missions; and 7. Attending short training courses (not more than 90 days), sports events, expositions and trade fairs.

INSTRUCTIONS FOR VISA APPLICATIONS REQUIREMENTS OF THE REPUBLIC OF NAMIBIA

Passport must be valid at least six (6) months after departure from Namibia

Provide:

Two (2) passport photos in colour

Original passport plus copies of the relevant pages therein

A copy of a return air ticket or confirmation of reservation / Invitation letter

A copy of valid credit card that is internationally-recognized or proof of survival in Namibia

Visa Fees

A fee of US 75 / RM 225 is payable for a tourist visa

A fee of US 135 / RM 395 is payable for a business visa

Submit ALL OF THE REQUIRED DOCUMENTS AND FEES to High Commission of the Republic of Namibia (Note: *Please do not disclose to courier services that fees are included*)

Courier services to and from the Namibian High Commission in Kuala Lumpur should be arranged and pre-paid by applicants

Business Hours: Monday through Fridays from 09h00 – 17h00 local time, with break between 13h00 – 14h00
